

Special Education at Charter Schools

Charter Schools Welcome Students with Exceptionalities

Charter Schools are required to provide special education supports and programs, just like every other public school in Pennsylvania. As the charter authorizer, Pittsburgh Public Schools provides oversight to ensure the Charter Schools adhere to federal and state requirements in order to guarantee that all students receive the most beneficial educational opportunities.

Charter Schools...

- Are considered Local Education Agencies (LEA).
- Must ensure a free appropriate public education (FAPE) is available to each child with a disability.
- Must comply with the Individuals with Disabilities Education Act (IDEA).
- Must comply with PA and federal special education laws and federal disability laws.
- Must comply with regulations specific to individuals with disabilities being educated in charter schools, which can be found in Chapter 711 of the regulations to the Pennsylvania School Code, 22 Pa. Code Ch. 711.
- Must comply with the following additional sections of Pennsylvania's school regulations:
 - Chapter 4, as it relates to academic standards and assessment.
 - Chapter 11, as it relates to pupil attendance.
 - Chapter 12, as it relates to students and student services.
- Must comply with the Family Educational Rights and Privacy Act of 1974 (FERPA).
- Must act in a timely manner to provide instructional materials in accessible formats (braille, enlarged print, digital or audio).

Children in Pennsylvania are eligible for special education services until they reach the age of 21 and cannot be denied entrance to a Charter School because of their disability.

Child Find Mandate

The Individuals with Disabilities
Education Act includes the
Child Find mandate

Child Find requires all school districts to identify, locate, and evaluate all children with disabilities, regardless of the severity of their disabilities.





Additional Mandates Regarding Suspension and Expulsion

- An informal hearing must be provided when a suspension exceeds three school days.
- Suspensions may not exceed 10 consecutive school days.
- Upon removal for more than 10 school days in the same school year, the Charter School is responsible for providing services to the student starting on the eleventh day.
- Expulsions require a formal hearing.
- Upon expulsion (i.e., exclusion from school for more than 10 consecutive days), the Charter School must provide the child with FAPE until notified in writing the child has enrolled in another public, private or approved private school.

Handling Disagreements about **Special Education Program**

- Parents may challenge the appropriateness of a special education program for a child.
- Parents can request an IEP meeting to discuss changing the child's program.
- Parents must be contacted in writing and consent anytime school officials suggest a reevaluation.
- Parents may request an IEP meeting, a mediation session or a due process hearing to resolve differences.
- Parents have the right to revoke their child's special education and related services. The school must issue a Notice of Recommended Educational Placement/Prior Written Notice (NOREP).
- Parents may file a complaint with the Pennsylvania Department of Education's Bureau of Special Education (BSE), Division of Monitoring and Improvement if a Charter School is not compliant with state and federal laws and regulations.
- Parents may also choose to file for IEP Facilitation, Mediation or Due Process through the Office for Dispute Resolution at odr-pa.org.

Is your young child developmentally delayed?

Children between the ages of three and admission to kindergarten may be eligible for Special Education services if screening tests indicate they are delayed in one of these critical areas: cognitive, communicative, physical, social/ emotional, and self-help.
