

# What are Community Schools?



They are schools built with the understanding that students often come to the classroom with challenges that impact their ability to learn, explore, and develop to their greatest potential. Because learning never happens in isolation, community schools provide free healthy meals, health care, tutoring, mental health counseling, and other tailored services before, during, and after school."




## **Community Schools Timeline**

# **4 SMART Clinic Pillars**





#### **SMART Clinic Vision**

"SMART (School health Model for Academics Reaching all Transforming lives) is an equitable school health solution that proactively engages, consents, and screens ALL students to identify risks and barriers to academic success. SMART then swiftly delivers interventions to eliminate or mitigate those barriers, thus creating the optimal environment to support learning.

SMART shares some similar characteristics with existing school-based health centers (SBHCs) in that it provides access to health and mental health services, as well as enhances behavioral health assessments and clinical management. However, SMART is uniquely differentiated from SBHCs in its singular goal of providing access and engaging all students (not just those who come in because of a health complaint); explicit focus on academic outcomes for students; full integration into the school's practices, policies, and culture; and financial sustainability structure."

SMART Clinics support the missing pillar for effective implementation of PPS Community Schools.





#### **PPS SMART Clinic Factoid**

#### The Role of PPS

Provide suitable space and provide utilities, custodial and maintenance services.

Share student directory information in accordance with FERPA regulations and PPS DREA approval.

Cooperate with GGC's preparation and management of the SMART® Center proforma budget.

Provide aggregate performance measure information (e.g., "ABC" of <u>A</u>ttendance, <u>B</u>ehavioral incidences, <u>C</u>ourse work grades), per DREA approval letter.

Name the SMART<sup>®</sup> Center, operated by MGG MD, in its annual FERPA notice.

#### The Role of Ginn Group/SMART

Fund start-up costs up to \$750K, including the payment of all required insurance premiums.

Conduct due diligence, perform analysis, create and manage operations plan and related SMART® Center pro forma budget.

Fund fee for MGG MD to serve as Medical Provider entity for 2021-2022 school year.

Provide the universal consent form.

Oversee all 5 phases of SMART Model Implementation.

Train MGG MD on SMART® Model *Active Access* and *Active Care* protocols
Report progress on performance measures at aggregate level only.

#### The Role of Dr. Gregorio

Care for all students and their families.

Bill insurance providers, when applicable, for care. Provide care to adults. Consent all patients for care.


Ensure that clinical personnel have and maintain the required credentials and licenses to treat children and adults

Maintain and pay all premiums on the insurance coverages.

Comply with HIPAA/FERPA

Function as the certified SMART® medical provider; in full fidelity to SMART® Model protocols and standards

# **Strengths**

- School principals are on board and one principal has received training

- An African American Doctor (Dr. Conti) is proposed for the on-site doctor who was recently recognized as a Hero in Health Care last month for Allegheny Health Network

#### Weaknesses

- Internal beliefs about the district's ability to sustain this initiative
- Staff were not involved in the process from the conception of the partnership
- Belief that an out of state partnership can't help locally





# **Opportunities**

- To actualize full-service community schools five years after the passing of the Community Schools policy
- CRNP's will be able to utilize all skills provided gained from this credential
- More Therapy Services will be provided on site






#### **Threats**

## Privatizing School Nurses: SMART Clinics in Providence Public Schools

From College Hill Independent reporters Olivia Cruz Mayeda and Mara Cavallaro: "By removing union school nurses and implementing private clinics directed by a for-profit business, the district has fundamentally restructured relationships of care in its public schools. There are now private incentives governing care where there previously were none. All of these concerns emphasize how privatization of healthcare undermines community control of basic medical and mental health services."
