Pittsburgh Public Schools Board Member Town Hall Listening Sessions Continue *New Virtual Town Hall Added*

Pittsburgh, PA – July 2, 2024 – There is still time for parents and families to share their hopes and dreams for their students as the Pittsburgh Public Schools (PPS) Board of Directors continue to hold town hall listening sessions across the city. Each Board Member has scheduled a community town hall listening session to gather public input on the recent recommendations within the District's Facilities Utilization Plan. Five town halls occurred during the month of June, with six more town halls scheduled for July. Each session is an essential part of ensuring that the voices of parents and families inform the development of a set of scenarios for the PPS community's consideration this August.
