- 6 We have one item on the agenda this
- 7 evening, ladies and gentlemen, it is a Personnel
- 8 Report, the Personnel Report from the Superintendent
- 9 of schools, and I assume, Mr. Superintendent, that
- 10 Miss Nicklos is going to handle this?
- MR. ROOSEVELT: That is correct.
- MR. ISLER: Miss Nicklos, you have the
- 13 floor.
- MS. NICKLOS: Thank you, Mr. President.
- And good evening.
- The personnel agenda tonight, May 2nd,
- 17 2006, contained personnel items for this month, for
- 18 your action.
- On page 1, are the new appointments.
- Page 1, the new appointments.
- Pages 1 through 3, you will find transfers;
- 22 both transfers with change of salary, as well as
- 23 transfers without change of salary.
- 24 And finally, in Addendum A, are positions
- 25 opened and closed.

- And this is the report, Mr. President.
- 2 MR. ISLER: Thank you.
- 3 Are there any questions for Miss Nicklos,
- 4 or the Superintendent, from any Board members?
- 5 I'm sorry. Mr. McCrea.
- 6 MR. McCREA: I just want to say that, you
- 7 know, I may not agree with everything in this packet,
- 8 but because this is something we are going to be
- 9 evaluating the Superintendent on, I will go ahead and
- 10 support it.
- 11 And I also want to make note that some of
- 12 these changes -- as a matter of fact, all of these
- 13 changes are either budget neutral, or have a very
- 14 small effect on the budget.
- Would you correct me on this, Mr. Camarda;
- 16 am I correct there?
- MR. CAMARDA: From my understanding, you
- 18 are correct.
- MR. ISLER: Mr. Brentley.
- MR. BRENTLEY: Yes.
- 21 Mr. President, I believe I expressed my
- 22 concerns before in the past, and I will express them
- 23 again.
- I have a lot of difficulty supporting this.
- I have expressed my concern about the

- 1 speed. It's just -- it's just unbelievable, in the
- 2 way that we are moving, the speed of the right sizing,
- 3 the speed of recommendations, the speed of hiring.
- Just this evening we have a new hire, that
- 5 we haven't even seen a resume; just received the
- 6 resume two days -- I mean, three or four minutes ago.
- 7 And so I will not be supporting this.
- I support the School District, and I
- 9 support all of the changes that we need to make, but
- 10 my concern is, is the way that it's -- we are going
- 11 about it, it's a little unfair to our professionals,
- 12 definitely unfair to those children who are in need,
- 13 and who we are now asking to adjust, and to change
- 14 their horses in the middle of the stream, I believe is
- 15 just unfair, and I believe it is very, very difficulty
- 16 to accept.
- So, Mr. President, sir, I will not be able
- 18 to support this report, this evening.
- MR. ISLER: Thank you, Mr. Brentley.
- 20 Any other comments?
- 21 Mr. Romaniello.
- MR. ROMANIELLO: I'd like to echo
- 23 Mr. McCrea's comments.
- We hired the Superintendent to do a job, he
- 25 brought on people who he feels can do the job, I want

- 1 to commend Mrs. Nicklos, and her staff, for being able
- 2 to get this done, desperate times, you know, so we
- 3 have a desperate problem here, and it needs to be
- 4 fixed immediately, and I -- I have all of the faith
- 5 that Mrs. Nicklos knows what she is doing, and has
- 6 done the right thing for this District.
- 7 So I would urge my fellow Board members to
- 8 support it.
- 9 MR. ISLER: Thank you.
- Mr. Taylor.
- MR. TAYLOR: Yes.
- I will not be supporting this agenda item,
- 13 as a whole. I am just disappointed, it is probably
- 14 too numerous, many philosophical problems I do have
- 15 with this.
- I cannot support, Mr. and Mrs. Doyle, or
- 17 Ms. Doyle, because again we only received this resume
- 18 just a few moments ago.
- And I think we should determine the process
- 20 in which the Board is able to at least meet some of
- 21 these potential candidates, before we vote on them.
- I just only wanted to just make clear that
- 23 I think the Board should really determine exactly
- 24 whether this co-principal, that has been proposed, and
- 25 whether that is just something that's done for the

- 1 current situation that we are in, we have never had
- 2 two very well paid principals, in one building. We
- 3 certainly have never had two principals at the
- 4 alternative center, that's always been a dean, for the
- 5 middle school students.
- So, I hope the Board is very clear that we
- 7 could be setting a precedent in many instances; when
- 8 things like this start, you know, sometimes they never
- 9 end.
- So we are spending probably more money than
- 11 we should be here.
- 12 And again, for other philosophical reasons,
- 13 about, I think the direction that this current report
- 14 is taking the District, I will be voting no against
- 15 the report as a whole.
- MR. ISLER: Thank you, Mr. Taylor.
- Mr. Dowd.
- MR. DOWD: I just want to seek a little bit
- 19 of clarification.
- Miss Nicklos, in the past, has it been our
- 21 practice to at times have co-principals in the
- 22 buildings, or is this something as Mr. Taylor says, we
- 23 have never done before?
- MS. NICKLOS: We have had co-principals in
- 25 the District.

- In fact, we were very successful with a
- 2 model in the District, we had co-principals at one
- 3 time at Allderdice, and co-principals at Westinghouse
- 4 High School.
- 5 MR. DOWD: Thank you.
- And I just want to see, one other point of
- 7 clarification, is this recommendation coming -- I
- 8 assume this recommendation coming forward to the
- 9 Board, is a recommendation that the administration
- 10 believes will improve the quality, performance of the
- 11 District as a whole, as well as these individual
- 12 schools; is that correct?
- MS. NICKLOS: That is correct.
- MR. DOWD: Great.
- Thank you.
- MR. ISLER: Mr. Sumpter.
- MR. SUMPTER: I have concern regarding the
- 18 position of co-principal, and I'm aware that there is
- 19 going to be efforts to work that relationship out.
- 20 However, if it does come to a point where
- 21 there needs to be some definitive understanding, as to
- 22 if one voice has to be in charge in certain
- 23 circumstances, that that is provided, so that we don't
- 24 have any conflict in those situations.
- MR. ISLER: Thank you.

- 1 Mr. Taylor.
- MR. TAYLOR: Again, I want to address the
- 3 misleading questions that Mr. -- that Dr. Dowd put
- 4 forward.
- 5 Miss Nicklos, when did that take place,
- 6 that the District had co-principals?
- 7 MS. NICKLOS: I am not certain of the date,
- 8 but we can certainly be more exact with that date.
- 9 MR. TAYLOR: Would you put that in the
- 10 1980's?
- 11 MS. NICKLOS: I'm not certain of the date,
- 12 and I would be happy to share those dates with the
- 13 Board.
- MR. TAYLOR: I mean, just speaking for
- 15 Westinghouse, Mr. Carr, who is sitting in the
- 16 audience, predated Lester Young, who I believe
- 17 appointment was early '90's, so I would probably say
- 18 that the co-principalship of Westinghouse was in the
- 19 1980's.
- Do you have any idea, Miss Nicklos, why
- 21 that did not become a model for across the District,
- 22 it was only tried in two places, and discontinued?
- MS. NICKLOS: I do not have any idea, or
- 24 the answer, as to why the model did not go across the
- 25 city. It was successful then, it was successful for

- 1 the purposes for which it happened.
- 2 MR. TAYLOR: Thank you, Mrs. Nicklos.
- MS. NICKLOS: Thank you.
- 4 MR. ISLER: Any other comments by Board
- 5 members?
- 6 Hearing none, Mr. Weiss, could we please
- 7 have a roll call on the Report for Human Resources.
- MR. WEISS: Mr. Brentley?
