- 21 colleagues, we have serious, serious business to
- 22 address, major issues in certain communities, the
- 23 community has been crying out for help, we can no
- 24 longer look in the different direction.
- 25 I will use my vote to simply abstain, but

- 1 I'm asking that we go back and do the things we should
- 2 be doing in terms of reevaluating the right sizing,
- 3 reevaluating the proposed school closings.
- 4 So I do believe we should be moving in a
- 5 completely different direction.
- I have asked that we slow the process down,
- 7 in terms of school closings, and how we are spending
- 8 dollars, and how we are moving, because we are
- 9 leaving, and creating a lot of victims.
- 10 So I'm asking again for my colleagues, as
- 11 we move forward, that we would please try to find a
- 12 way to address some of those issues from those
- 13 particular communities that are hurting.
- 14 Thank you, very much.
- DR. ALLEN: Mr. Weiss, may we have a roll
- 16 call for the office of president, for
- 17 Theresa Colaizzi.
- MR. WEISS: You can indicate your vote for
- 19 Mrs. Colaizzi by voting yes, since there is only one
- 20 candidate.
