- 21 transactions, estates and trusts and criminal law.
- 22 is licensed both in Pennsylvania and in this District

- 2 as well. In 2000, he received the Homer S. Brown
- 3 Outstanding Attorney Award and in 2001 was elected
- 4 president of the Homer S. Brown Law Association. He

- 6 History & Landmarks Foundation, the Negro Education
- 7 Emergency Drive and the NAACP.
