MR. WEISS: I want to welcome you all to the reorganization meeting of the Pittsburgh Board of Public Education. This is a special evening. We have four newly-elected Board members and one re-elected member who will take their oaths of office from a very special guest we have this evening, and then we'll proceed for the reorganization meeting.

It's my pleasure to introduce to you the Honorable Kim Berkeley Clark. Judge Clark is the Administrative Judge of the Family Division of the Court of Common Pleas, so she has --

MR. WEISS: She has lots of contact with our students and our staff, and she's always had a very, very productive relationship with the School District.

Many, many years ago when Judge Clark was much younger, she interviewed for a job with me when I was County Solicitor. She wisely decided to take a job with the District Attorney's office, and the rest as they say is history.

I also had the pleasure of working for many years with Judge Clark's father who was the resident expert and story teller at the Department of

Elections. He was called Knowledge Clark, and I count him as one of my closest friends and always liked the time I spent with him.

Judge Clark will administer the oath of office to our four new members and Mr. Sumpter is our re-elected member, so I would like to ask her to come forward. I'll turn the program over to Judge Clark. Thank you.

JUDGE CLARK: Just before I give the oath, I am very privileged to do this. I think this is a very special thing for a judge to do, to administer oath -- an oath of office for a public servant. I'm a big believer in public service, and I can't thank the members of the School Board enough for the service that they give to our community.

Educational success is really important to our young people, and we know that children who have school stability and good experiences in school do better in life no matter what their circumstances are as they grow up in their community.

So I applaud you for your willingness to serve, and it's not an easy job being a member of a school board in any community, but I'm confident that you're all up to the task of it.

And so I just say congratulations and thank you again on behalf of all of our judges in the Fifth Judicial District, but, particularly, in the Family Division because we have a lot of contact with the members of the various school boards and, in particular, the City of Pittsburgh. We have a good working relationship and $I$ hope that it continues for many, many, many, many years to come, so thank you. (Applause.)

And I want to remind the public that regardless of what goes on here, keep in mind the most important thing is that we are volunteers, and often times people forget about that.

But I just want to put out a few words on behalf of my colleague Dr. Regina Holley, and I'm hoping and encouraging my colleagues to support her. The public is watching.

Over the last seven or eight years, we as a District have been down a pretty bumpy road, and a lot of the things that we've done, we kind of rubbed the
public the wrong way and they weren't the right decisions.

And I am hoping and asking that my colleagues would not only support Dr. Holley, but while people are watching and getting ready to text to their friends and their employees the direction of this Board that we be very, very mindful of the importance of showing that we can deliver a unanimous decision for the President's position in support of Dr. Holley.

While everybody around here have their own separate skill sets, I mean, wonderful skill sets here, nobody can stand in and boast and say they've got 30 -plus years in the classroom and as a principal in this District, and somehow, some way, we have to look past our differences and put our best team on the field, and in my opinion, Dr. Holley represents it.

I'm here with close to 16 years of service. I would love to serve as President. It would be an honor, but we got to put the first string on the field and to deal with the issues that we are getting ready to walk and head on into, it's important that we have someone who can speak the language, who's been there, who understands a teacher, who can send a shock wave through the District that it's okay, we are now going
to be proactive in working with everyone.
And so I'm asking my colleagues if they would strongly consider -- this is not anything against anyone else who is nominated, but it's time. It's just time. This is my third time nominating Dr. Holley.

We have never had anyone with this kind of experience, and we have to find a way to simply advance their names forward, put them in key leadership positions and then learn and grow as we move together as a Board.

Thank you so much, and I am hoping that we will be able to simply appoint or give Dr. Holley the vote of confidence that she needs to represent us throughout the District. Thank you so much.

MRS. HAZUDA: Thank you, Mr. Brentley.
Does anyone else want to make comments? Mr. Sumpter.

MR. SUMPTER: Thank you, Mrs. Hazuda.
Eight years ago when $I$ was elected, my main priority was to make solid decisions that would equitably affect the future of our children. It has also been a goal of mine to work collaboratively with fellow Board members, fellow Board directors, as well as to serve with a purpose.

During my tenure as Board Director, I have represented Pittsburgh Public Schools on the Pennsylvania School Board Association as regional director for Region 13 where $I$ was challenged to bring innovative, practical and applicable ideas to our school system.

My experience in the District consists of being First Vice President, Second Vice President, Chair of the Education Committee, Board liaison to the Early Childhood Policy Council, member of the Labor Relations Committee, member of the PIAA District 8 Committee, member of the Policy Review Committee and a member of the Business and Finance Committee.

With that said, my record shows that in these eight years I have learned a great deal about what this District needs. I have learned how to make tough decisions and how to work with my fellow directors and Central Administration for the betterment of our children and the District. I would appreciate your support as President to move this District forward in the direction of being a world-class school district. Thank you.

But I want to remind folks while you see what's going on here there is a strong need for change, and when we see the same folks getting key leadership positions, there's very little that could possibly change, so we are now going around for thirds and fourths for some individuals who have served, and so there is no law and there is no rule, but a professional curtesy would be to slowly to allow
others an opportunity of leadership, an opportunity to take responsibilities and to also see what they're capable of sharing and bringing to the District.

When one or two individuals constantly
manages to stay in the leadership position, you will get what we have been getting, and that is unfortunate. That is really unfortunate here.

No, there are no rules, and I want to make that very clear. There are no rules, but the purpose is to get everybody active and everybody involved and to share instead of having one position, one or two individuals always in the leadership position it is their influence that is put over the leadership, and it constantly, constantly strangles the progress of this District.

So I say that to share with folks so that you can understand what's going on here. You can clearly look at the records, and certain individuals always manage to stay in a leadership position almost as if to watch over certain individuals to make sure you never do what is right for children or make sure you never do what's right for this District. It is a sad day. It is a sad day. Thank you.
