SCHOOL VOLUNTEER CLEARANCE PROCEDURES

Policy

All school volunteers who will be responsible for the welfare of students or who will have direct contact with children are required to submit clearances under the provisions of Policy 920 – Background Checks and 23 Pa.C.S. §6344.2. Prior to commencing volunteer services, the volunteer must submit a report of criminal history from the Pennsylvania State Police, Child Abuse Certification, and a report of federal criminal history (FBI report). The clearances must be no more than three (3) years old at any time while the volunteer is providing services and must be renewed every thirty-six (36) months while the volunteer continues to provide services.

A prospective volunteer <u>may</u> be excused from providing the report of federal criminal history (FBI report) only if s/he submits a signed affidavit affirming that the volunteer is not disqualified from service (see form below) and can demonstrate that s/he has been a resident of Pennsylvania for all of the past ten (10) years. The District reserves the right to require a FBI report even if the volunteer submits the waiver request form.

Cost

The volunteer is responsible for the cost of obtaining clearances required by law. However, Title I schools may use Title I parent involvement funding to reimburse parents/guardians for the cost of obtaining clearances. School affiliated organizations (PTOs, PTAs, PSCCs) may also choose to assist parents with the cost of obtaining clearances. Prior to reimbursing a parent for the cost of clearances, the parent must actually provide the volunteer services applied for at the school. In no case will the cost of clearances be reimbursed if the prospective volunteer does not actually fulfill any volunteer services.

The PA State Criminal History Report is \$10, the Child Abuse Certification is \$10, and the FBI Report is \$28.75.

Procedure

Prior to providing volunteer services for a school or volunteering on a school trip, the volunteer must submit the following to the Title Programs Office:

- The completed Intake Form for Volunteers (Attachment 1);
- The PA State Criminal History Report (obtained online);
- A copy of the Child Abuse Certification (obtained online); AND
- The FBI Criminal History Report (fingerprinting required FBI report access code will be provided; apply online) OR a signed PA Resident Form (Attachment 2) AND Waiver Request (Attachment 3)

If the volunteer does not have internet access or requires assistance with the process, the volunteer should contact the school or Title Programs Office for assistance.

The reports (including FBI report access code) and all necessary forms may be submitted in a sealed envelope to the school for delivery to the Title Programs Office, or for increased confidentiality, the clearances and required information may be emailed, mailed or delivered directly to the Title Programs Office at:

If the Intake Form does not include the name of the school or schools where the services will be performed or any required information is missing, the clearances will not be processed.

Volunteer approval will be communicated **to the school(s)** after central office review of the submitted materials. The Intake Form for Volunteers will be stamped "CLEARED" or "NOT CLEARED," and returned to the school for their records. It is at this time that a cleared volunteer may begin their volunteer assignment. The school will not receive copies of the criminal history reports or child abuse certification. The reports will remain confidential and will be maintained in the Title Programs Office and/or Law Department.

In instances where there is a criminal history, the reports are forwarded to the Law Department for review. This secondary review may extend the clearance review period so please ensure that reports are submitted at least 30 days prior to a scheduled volunteer event.

Additional Information

Once parents/guardians are cleared, they are cleared for thirty-six (36) months from the date of their criminal history reports and child abuse certification. This means that parents/guardians have to get new clearances once any of their reports expires. Copies of all clearances will be kept on file in the designated central District office.

The Title Programs Office is available to assist volunteers and schools throughout the clearance process.
