Pittsburgh Public Schools Releases Preliminary District Empowerment Plan for Public Comment

PITTSBURGH, November 13, 2006 – Today, Pittsburgh Public Schools released a preliminary draft of the District's Empowerment Plan for public comment. The Empowerment Plan will serve as the District's comprehensive plan for meeting the State's requirements as a result of the District's designation as a Commonwealth Partnership School District in July 2006. Additionally this comprehensive plan will meet the District's obligation to submit a District Improvement Plan as a result of its Corrective Action I status under No Child Left Behind.

The District received the Commonwealth Partnership School District designation because it met the following criteria:

- A fifteen percent or more decline in student enrollment during the immediately preceding five-year period.
- A loss of revenue during the immediately preceding three-year period due to the removal of one or more of the sources of revenue under Section 652.1 (the School District Taxing Statute).
- A certain level of equalized millage.

As a result of the Commonwealth Partnership designation the District was placed on the Secretary's Education Empowerment List. In accordance with this designation the District must submit a plan for more efficient and effective management of the District's special education program. Additionally the District was required to appoint an 11 member Empowerment Team to develop a plan to improve the academic performance of the Pittsburgh Public Schools and give priority consideration to improving the financial stability of the District. The plan also must address increasing the level of achievement of African American students.
